#### Indication of any immediate medical attention and special treatment needed

for irritant gas exposures:

- ▶ the presence of the agent when it is inhaled is evanescent (of short duration) and therefore, cannot be washed away or otherwise removed
- ▶ arterial blood gases are of primary importance to aid in determination of the extent of damage. Never discharge a patient significantly exposed to an irritant gas without obtaining an arterial blood sample.
- ▶ supportive measures include suctioning (intubation may be required), volume cycle ventilator support (positive and expiratory pressure (PEEP), steroids and antibiotics, after a culture is taken
- ▶ If the eyes are involved, an ophthalmologic consultation is recommended

For acute or short term repeated exposures to ammonia and its solutions:

- ▶ Mild to moderate inhalation exposures produce headache, cough, bronchospasm, nausea, vomiting, pharyngeal and retrosternal pain and conjunctivitis. Severe inhalation produces laryngospasm, signs of upper airway obstruction (stridor, hoarseness, difficulty in speaking) and, in excessively, high doses, pulmonary oedema.
- ▶ Warm humidified air may soothe bronchial irritation.
- ▶ Test all patients with conjunctival irritation for corneal abrasion (fluorescein stain, slit lamp exam)
- ▶ Dyspneic patients should receive a chest X-ray and arterial blood gases to detect pulmonary oedema.

## SECTION 7 Handling and storage

### Precautions for safe handling

Mixtures of ammonia and air lying within the explosive limits can occur above aqueous solutions of varying strengths.</li> <li>▶ Avoid contact with sodium hydroxide, iron and cadmium.</li> <li>▶ Several incidents involving sudden "boiling" (occasionally violent) of a concentrated solution (d, 0.880, 35 wt %.) have occurred when screw-capped winchesters are opened. These are attributable to supersaturation of the solution with gas caused by increases in temperature subsequent to preparation and bottling. The effect is particularly marked with winchesters filled in winter and opened in summer.</li> <li>▶ Ammonia polymerises violently with ethylene oxide.</li> <li>▶ Ammonia attacks some coatings, plastics and rubber.</li> <li>▶ Attacks copper, bronze, brass, aluminium, steel and their alloys.</li> </ul> <p>None known</p>

**Notes:** Occupational exposure banding is a process of assigning chemicals into specific categories or bands based on a chemical's potency and the adverse health outcomes associated with exposure. The output of this process is an occupational exposure band (OEB), which corresponds to a range of exposure concentrations that are expected to protect worker health.

Reports of skin and eye irritation and chronic headaches have been reported in workers exposed to 1-methyl-2-pyrrolidone. The Australian ES is based on a 10-fold uncertainty factor of the no-observable-adverse-effect level (NOAEL) of 24 ppm where adverse respiratory effects were observed in a 4-week inhalation study in rats.

NOTE: Detector tubes for ammonia, measuring in excess of 1 ppm, are commercially available.

The TLV-TWA is thought to be protective against irritation of the eyes and respiratory tract and minimise discomfort among workers that are not inured to its effects and systemic damage. Acclimatised persons are able to tolerate prolonged exposures of up to 100 ppm without symptoms. Marked irritation has been seen in persons exposed to ammonia concentrations between 50 and 100 ppm only when the exposures involved sudden concentration peaks which do not permit short-term acclimatisation. The detoxification capacity of the liver is significant since the amount of ammonia formed endogenously in the intestines markedly

exceeds that from external sources.

<b>Appropriate engineering controls</b>	<p>CARE: Explosive vapour air mixtures may be present on opening vessels which have contained liquid ammonia. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection.</p> <p>The basic types of engineering controls are:</p> <p>Process controls which involve changing the way a job activity or process is done to reduce the risk.</p> <p>Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. Ventilation can remove or dilute an air contaminant if designed properly. The design of a ventilation system must match the particular process and chemical or contaminant in use. Employers may need to use multiple types of controls to prevent employee overexposure.</p> <p>Local exhaust ventilation usually required. If risk of overexposure exists, wear approved respirator. Correct fit is essential to obtain adequate protection. Supplied-air type respirator may be required in special circumstances. Correct fit is essential to ensure adequate protection.</p> <p>An approved self contained breathing apparatus (SCBA) may be required in some situations.</p> <p>Provide adequate ventilation in warehouse or closed storage area. Air contaminants generated in the workplace possess varying "escape" velocities which, in turn, determine the "capture velocities" of fresh circulating air required to effectively remove the contaminant.</p>

Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. Velocity generally decreases with the square of distance from the extraction point (in simple cases). Therefore the air speed at the extraction point should be adjusted, accordingly, after reference to distance from the contaminating source. The air velocity at the extraction fan, for example, should be a minimum of 1-2 m/s (200-400 f/min) for extraction of solvents generated in a tank 2 meters distant from the extraction point. Other mechanical considerations, producing performance deficits within the extraction apparatus, make it essential that theoretical air velocities are multiplied by factors of 10 or more when extraction systems are installed or used.

<p><b>Hands/feet protection</b></p>	<ul style="list-style-type: none"> <li>▶ Wear chemical protective gloves, e.g. PVC.</li> <li>▶ Wear safety footwear or safety gumboots, e.g. Rubber</li> </ul> <p>The selection of suitable gloves does not only depend on the material, but also on further marks of quality which vary from manufacturer to manufacturer. Where the chemical is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.</p> <p>The exact break through time for substances has to be obtained from the manufacturer of the protective gloves and has to be observed when making a final choice.</p> <p>Personal hygiene is a key element of effective hand care. Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended.</p> <p>Suitability and durability of glove type is dependent on usage. Important factors in the selection of gloves include:</p> <ul style="list-style-type: none"> <li>· frequency and duration of contact,</li> <li>· chemical resistance of glove material,</li> <li>· glove thickness and</li> <li>· dexterity</li> </ul> <p>Select gloves tested to a relevant standard (e.g. Europe EN 374, US F739, AS/NZS 2161.1 or national equivalent).</p> <ul style="list-style-type: none"> <li>· When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time greater than 240 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended.</li> <li>· When only brief contact is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended.</li> <li>· Some glove polymer types are less affected by movement and this should be taken into account when considering gloves for long-term use.</li> <li>· Contaminated gloves should be replaced.</li> </ul> <p>As defined in ASTM F-739-96 in any application, gloves are rated as:</p> <ul style="list-style-type: none"> <li>· Excellent when breakthrough time &gt; 480 min</li> <li>· Good when breakthrough time &gt; 20 min</li> <li>· Fair when breakthrough time &lt; 20 min</li> <li>· Poor when glove material degrades</li> </ul> <p>For general applications, gloves with a thickness typically greater than 0.35 mm, are recommended.</p> <p>It should be emphasised that glove thickness is not necessarily a good predictor of glove resistance to a specific chemical, as the permeation efficiency of the glove will be dependent on the exact composition of the glove material. Therefore, glove selection should also be based on consideration of the task requirements and knowledge of breakthrough times.</p> <p>Glove thickness may also vary depending on the glove manufacturer, the glove type and the glove model. Therefore, the manufacturers technical data should always be taken into account to ensure selection of the most appropriate glove for the task.</p> <p>Note: Depending on the activity being conducted, gloves of varying thickness may be required for specific tasks. For example:</p> <ul style="list-style-type: none"> <li>· Thinner gloves (down to 0.1 mm or less) may be required where a high degree of manual dexterity is needed. ## SECTION 11 Toxicological information

### Information on toxicological effects

<p><b>Inhaled</b></p>	<p>The material is not thought to produce adverse health effects or irritation of the respiratory tract (as classified by EC Directives using animal models). Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable control measures be used in an occupational setting.</p> <p>Inhalation of high vapour concentrations of N-methyl-2-pyrrolidone (NMP) may produce mucous membrane irritation, headache, giddiness, mental confusion and nausea. Fatalities were not recorded following inhalation of 180-200 mg/m<sup>3</sup> for 2 hours by mice and following a 6 hour exposure to saturated vapours by rats.</p> <p>Laboratory animals exposed to concentrations of 50 ppm for 8 hours daily for 20 days or 370 ppm for 6 hours daily for 10 days showed no gross or histopathological abnormalities</p> <p>The highly irritant properties of ammonia vapour result as the gas dissolves in mucous fluids and forms irritant, even corrosive solutions.</p> <p>Inhalation of the ammonia fumes causes coughing, vomiting, reddening of lips, mouth, nose, throat and conjunctiva while higher concentrations can cause temporary blindness, restlessness, tightness in the chest, pulmonary oedema (lung damage), weak pulse and cyanosis.</p> <p>Inhalation of high concentrations of vapour may cause breathing difficulty, tightness in chest, pulmonary oedema and lung damage. Brief exposure to high concentrations &gt; 5000 ppm may cause death due to asphyxiation (suffocation) or fluid in the lungs.</p> <p>Prolonged or regular minor exposure to the vapour may cause persistent irritation of the eyes, nose and upper respiratory tract. Massive ammonia exposures may produce chronic airway hyperactivity and asthma with associated pulmonary function changes. The average nasal retention of ammonia by human subjects was found to be 83%.</p>
<p><b>Ingestion</b></p>	<p>The material has <b>NOT</b> been classified by EC Directives or other classification systems as "harmful by ingestion". This is because of the lack of corroborating animal or human evidence. The material may still be damaging to the health of the individual, following ingestion, especially where pre-existing organ (e.g liver, kidney) damage is evident. Present definitions of harmful or toxic substances are generally based on doses producing mortality rather than those producing morbidity (disease, ill-health). Gastrointestinal tract discomfort may produce nausea and vomiting. In an occupational setting however, ingestion of insignificant quantities is not thought to be cause for concern.</p> <p>Human metabolism allows detoxification of ammonia, however toxic effects appear if this mechanism is overwhelmed by other than small doses.</p> <p>Ingestion of ammonium salts may produce local irritation, nausea, vomiting and diarrhoea. Very large doses of ammonium salts may produce a drop in blood pressure, collapse, central nervous system disorders, spasms, narcosis, respiratory paralysis and haemolysis.</p> <p>Large doses of ammonium salts may be sufficiently absorbed to produce diuresis and systemic ammonia poisoning. Such poisonings have been described after parenteral administration of the salts and produce flaccidity of facial muscles, tremor, generalised discomfort, anxiety and impairment of motor performance, recognition and of critical flicker fusion. Such a clinical picture resembles that found in terminal liver failure - elevated levels of ammonia are found regularly in advanced liver disease.</p>
<p><b>Skin Contact</b></p>	<p>Evidence exists, or practical experience predicts, that the material either produces inflammation of the skin in a substantial number of individuals following direct contact, and/or produces significant inflammation when applied to the healthy intact skin of animals, for up to four hours, such inflammation being present twenty-four hours or more after the end of the exposure period.</p> <p>Skin irritation may also be present after prolonged or repeated exposure; this may result in a form of contact dermatitis (nonallergic). The dermatitis is often characterised by skin redness (erythema) and swelling (oedema) which may progress to blistering (vesiculation), scaling and thickening of the epidermis. At the microscopic level there may be intercellular oedema of the spongy layer of the skin (spongiosis) and intracellular oedema of the epidermis.</p> <p>The material may accentuate any pre-existing dermatitis condition</p> <p>Skin contact is not thought to have harmful health effects (as classified under EC Directives); the material may still produce health damage following entry through wounds, lesions or abrasions.</p> <p>Prolonged contact with N-methyl-2-pyrrolidone (NMP) reportedly causes severe dermatitis with redness, cracking, swelling, blisters and oedema.</p> <p>An instance of severe skin irritation after a few days work with NMP shows latex rubber gloves as giving insufficient protection. A review article casts doubts on reliability of animal single patch tests, i.e Draize tests. [Irritant Cutaneous Reaction to NMP, Contact Dermatitis 27: 148-150, 1992]</p> <p>Open cuts, abraded or irritated skin should not be exposed to this material</p> <p>Entry into the blood-stream through, for example, cuts, abrasions, puncture wounds or lesions, may produce systemic injury with harmful effects. Examine the skin prior to the use of the material and ensure that any external damage is suitably protected.</p> <p>Mild irritation is produced on moist skin when vapour concentrations of ammonia exceed 10000 ppm. High vapour concentrations (&gt;30000 ppm) or direct contact with solutions produces severe pain, a stinging sensation, burns and vesiculation and possible brown stains. Extensive burning may be fatal. Vapour exposure may, rarely, produce urticaria.</p>
<p><b>Eye</b></p>	<p>Evidence exists, or practical experience predicts, that the material may cause eye irritation in a substantial number of individuals and/or may produce significant ocular lesions which are present twenty-four hours or more after instillation into the eye(s) of experimental animals.</p> <p>Repeated or prolonged eye contact may cause inflammation characterised by temporary redness (similar to windburn) of the conjunctiva (conjunctivitis); temporary impairment of vision and/or other transient eye damage/ulceration may occur.</p> <p>Direct contact with the liquid N-methyl-2-pyrrolidone (NMP) may produce painful burning or stinging of the eyes and lids, watering and inflammation of the conjunctiva and temporary corneal clouding.</p>

<b>Chronic</b>	<p>There is sufficient evidence to provide a strong presumption that human exposure to the material may result in the development of heritable genetic damage, generally on the basis of</p> <ul style="list-style-type: none"> <li>- appropriate animal studies,</li> <li>- other relevant information</li> </ul>									
	<p>There is sufficient evidence to establish a causal relationship between human exposure to the material and subsequent developmental toxic effects in the off-spring.</p> <p>The teratogenic potential, subchronic and long term inhalation toxicity of N-methyl-2-pyrrolidone (NMP) has been studied in rats. No evidence of nephrotoxicity was seen.</p> <p>No carcinogenic effects were observed. Very high doses are embryotoxic to rats and mice. Reproductive effects have been reported in animals.</p> <p>Prolonged or repeated minor exposure to ammonia gas/vapour may cause long-term irritation to the eyes, nose and upper respiratory tract. Repeated exposure or prolonged contact may produce dermatitis, and conjunctivitis.</p> <p>Other effects may include ulcerative changes to the mouth and bronchial and gastrointestinal disturbances. Adaptation to usually irritating concentrations may result in tolerance. In animals, repeated exposures to sub-lethal levels produces adverse effects on the respiratory tract, liver, kidneys and spleen. Exposure at 675 ppm for several weeks produced eye irritation in dogs and rabbits; corneal opacity, covering between a quarter to one half of the total surface area, was evident in rabbits.</p>

	<p>Exposure to the material may result in a possible risk of irreversible effects. The material may produce mutagenic effects in man. This concern is raised, generally, on the basis of appropriate studies using mammalian somatic cells <i>in vivo</i>. However, significant adverse reproductive effects have been noted following a single exposure</p> <p>Carbendazim is well absorbed (80-85%) after oral exposure but much less so by dermal exposure. Absorbed carbendazim is metabolised into many compounds within the organism. The main metabolites are 5-HBC and 5,6-HOBC-N-oxides. The tissue distribution of carbendazim showed no bioconcentration. In the rat, the highest concentration after oral carbendazim administration (&lt; 1% of the dose) occurred in the liver. It was distributed as carbendazim in the mitochondria, 5-HBC in the cytosol, and 2-aminobenzimidazole (2-AB) in the microsomes. Carbendazim is excreted in the urine and faeces within 72 h after oral dosing in rats. In rats and mice, high doses of carbendazim, both in the diet and by gavage, affect certain liver microsomal enzymes.</p> <p><b>Short-term exposure</b> Dietary administration of carbendazim for up to 90 days produced slight effects on liver weight in female rats exposed to 360 mg/kg body weight per day. In a 90-day gavage study in the rat, the NOEL was 16 mg/kg per day based on hepatotoxicity. Short-term feeding studies on dogs were not adequate for establishing a NOEL. A 10-day dermal study in the rabbit revealed no systemic toxicity at the only dose tested (200 mg/kg).</p> <p><b>Long-term exposure</b> Male and female rats fed 2500 mg/kg diet showed reduced erythrocyte count and haemoglobin and haematocrit values. No liver-related toxicity was noted. Male rats fed 2500 mg/kg diet or more presented a marginal increase in diffuse testicular atrophy and prostatitis. The NOEL in the rat is 500 mg/kg diet.</p> <p>Male and female mice fed 5000 mg/kg diet showed increased absolute liver weight. There was also significant centrilobular hypertrophy, necrosis and swelling of the liver in male mice fed 1500 mg/kg diet.</p> <p><b>Reproduction, embryotoxicity and teratogenicity</b> Carbendazim was without adverse effects on reproduction when it was fed to rats in a three-generation reproduction study at levels up to and including 500 mg/kg diet. Male fertility was depressed in rats when carbendazim (200 mg/kg per day) was administered by gavage for 85 days. A dose of 50 mg/kg body weight per day in this study caused a significant decrease in epididymal sperm count.</p> <p>Following a single oral dose to rats, histological examination revealed early (0-2 days) disruption of spermatogenesis with occlusion of efferent ducts and increased testicular weights at 100 mg/kg body weight. No effect was observed at 50 mg/kg in this single dose study. These effects persisted until day 70 in rats treated with 400 mg/kg.</p> <p>Carbendazim caused an increase in malformations and anomalies in rats when administered at daily dose levels greater than 10 mg/kg on days 7-16 of gestation. There was a slightly decreased rate of implantation in rabbits administered 20 and 125 mg/kg per day on days 7-19 of gestation and an increased incidence of resorption at 125 mg/kg per day. Maternal toxicity was observed at 20 mg/kg per day and 125 mg/kg per day in the rat and rabbit, respectively.</p> <p>In rats there was a significant increase in foetal malformations at 90 mg/kg per day. These consisted primarily of hydrocephaly, microphthalmia, anophthalmia, malformed scapulea and axial skeletal malformations (vertebral, rib and sternebral fusions, exencephaly, hemivertebrae and rib hyperplasia). However, in the rabbit there were no significant malformations.</p> <p><b>Mutagenicity and related end-points</b> Assays in mammalian and non-mammalian systems <i>in vitro</i> and <i>in vivo</i> and in somatic cells as well as in germ cells show that carbendazim does not interact with DNA, induce point mutation or cause germ cell mutation. Carbendazim does, however, cause numerical chromosome aberrations (aneuploidy and/or polyploidy) in experimental systems, both <i>in vitro</i> and <i>in vivo</i>.</p> <p><b>Carcinogenicity:</b> Benomyl and its decomposition product carbendazim feeding resulted in an increase in the incidence of hepatocellular tumours in CD-1 and SPF Swiss mice. A carcinogenicity study of carbendazim using CD-1 mice showed a statistically significant dose-related increase in the incidence of hepatocellular neoplasia in females. There was also a statistically significant increase in the mid-dose (1500 mg/kg diet) males, but not in the high-dose males because of a high mortality rate. A carcinogenicity study of carbendazim in a genetically related mouse strain, SPF mice (Swiss random strain) at doses of 0, 150, 300 and 1000 mg/kg diet (increased to 5000 mg/kg during the study) showed an increase in the incidence of combined hepatocellular adenomas and carcinomas.</p> <p>Carcinogenicity studies of both benomyl and carbendazim in rats were negative.</p> <p><b>Mechanism of toxicity - mode of action</b> The biological effects of benomyl and carbendazim result from their interaction with cell microtubules. These structures are involved in vital functions such as cell division, which is inhibited by benomyl and carbendazim. Benomyl and carbendazim toxicities in mammals are linked to microtubular dysfunction. Benomyl and carbendazim, as well as other benzimidazole compounds, display species-selective toxicity. This selectivity is, at least in part, explained by the different binding of benomyl and carbendazim to tubulins of target and non-target species</p> <p>[ * The Pesticides Manual, Incorporating The Agrochemicals Handbook, 10th Edition, Editor Clive Tomlin, 1994, British Crop Protection Council]</p>

Repeated daily doses of 450 mg/kg body weight administered to the skin caused painful and severe haemorrhage and eschar formation in rabbits. These</p>
	<p>adverse effects have not been seen in workers occupationally exposed to pure NMP, but they have been observed after dermal exposure to NMP used in cleaning processes. No sensitisation potential has been observed.</p> <p>In acute toxicity studies in rodents, NMP showed low toxicity. Uptake of oral, dermal, or inhaled acutely toxic doses causes functional disturbances and depressions in the central nervous system. Local irritation effects were observed in the respiratory tract when NMP was inhaled and in the pyloric and gastrointestinal tracts after oral administration. In humans, there was no irritative effect in the respiratory system after an 8-h exposure to 50 mg/m<sup>3</sup>.</p> <p><b>Repeat dose toxicity:</b> There is no clear toxicity profile of NMP after multiple administration. In a 28-day dietary study in rats, a compound-related decrease in body weight gain was observed in males at 1234 mg/kg body weight and in females at 2268 mg/kg body weight. Testicular degeneration and atrophy in males and thymic atrophy in females were observed at these dose levels. The no-observed-adverse-effect level (NOAEL) was 429 mg/kg body weight in males and 1548 mg/kg body weight in females. In a 28-day intubation study in rats, a dose-dependent increase in relative liver and kidney weights and a decrease in lymphocyte count in both sexes were observed at 1028 mg/kg body weight. The NOAEL in this study was 514 mg/kg body weight. In another rat study, daily dietary intake for 90 days caused decreased body weights at doses of 433 and 565 mg/kg body weight in males and females, respectively. There were also neurobehavioural effects at these dose levels. The NOAELs in males and females were 169 and 217 mg/kg body weight, respectively.</p> <p>The toxicity profile after exposure to airborne NMP depends strongly on the ratio of vapour to aerosol and on the area of exposure (i.e., head-only or whole-body exposure). Because of higher skin absorption for the aerosol, uptake is higher in animals exposed to aerosol than in those exposed to vapour at similar concentrations. Studies in female rats exposed head only to 1000 mg/m<sup>3</sup> showed only minor nasal irritation, but massive mortality and severe effects on major organs were observed when the females were whole-body exposed to the same concentration of coarse droplets at high relative humidity. Several studies in rats following repeated exposure to NMP at concentrations between 100 and 1000 mg/m<sup>3</sup> have shown systemic toxicity effects at the lower dose levels. In most of the studies, the effects were not observed after a 4-week observation period.</p> <p>In rats, exposure to 3000 mg NMP/m<sup>3</sup> (head only) for 6 h/day, 5 days/week, for 13 weeks caused a decrease in body weight gain, an increase in erythrocytes, haemoglobin, haematocrit, and mean corpuscular volume, decreased absolute testis weight, and cell loss in the germinal epithelium of the testes. The NOAEL was 500 mg/m<sup>3</sup>.</p> <p>There are no data in humans after repeated-dose exposure.</p> <p><b>Carcinogenicity:</b> NMP did not show any clear evidence for carcinogenicity in rats exposed to concentrations up to 400 mg/m<sup>3</sup> in a long-term inhalation study.</p> <p><b>Genotoxicity:</b> The mutagenic potential of NMP is weak. Only a slight increase in the number of revertants was observed when tested in a <i>Salmonella</i> assay with base-pair substitution strains. NMP has been shown to induce aneuploidy in yeast <i>Saccharomyces cerevisiae</i> cells. No investigations regarding mutagenicity in humans were available.</p> <p><b>Reproductive toxicity:</b> In a two-generation reproduction study in rats, whole-body exposure of both males and females to 478 mg/m<sup>3</sup> of NMP vapour for 6 h/day, 7 days/week, for a minimum of 100 days (pre-mating, mating, gestation, and lactation periods) resulted in a 7% decrease in fetal weight in the F1 offspring. A 4-11% transient, non-dose-dependent decrease was observed in the average pup weight at all exposure levels tested (41, 206, and 478 mg/m<sup>3</sup>).</p> <p><b>Developmental toxicity:</b> When NMP was administered dermally, developmental toxicity was registered in rats at 750 mg/kg body weight. The observed effects were increased preimplantation losses, decreased fetal weights, and delayed ossification. The NOAEL for both developmental effects and maternal toxicity (decreased body weight gain) was 237 mg/kg body weight. Inhalation studies in rats (whole-body exposure) demonstrated developmental toxicity as increased preimplantation loss without significant effect on implantation rate or number of live fetuses at 680 mg/m<sup>3</sup> and behavioural developmental toxicity at 622 mg/m<sup>3</sup>. In an inhalation study (whole-body exposure), the NOAEL for maternal effects was 100 mg/m<sup>3</sup>, and the NOAEL for developmental effects was 360 mg/m<sup>3</sup>.</p> <p>A tolerable inhalation concentration, 0.3 mg/m<sup>3</sup>, based on mortality and organ damage, is expected to be protective against any possible reproductive toxicity. Similarly, an oral tolerable intake of 0.6 mg/kg body weight per day, based on a 90-day study, is expected to provide adequate protection against possible reproductive effects. Because of non-existent data on the exposure of the general population and very limited information on occupational exposure, no meaningful risk characterisation can be performed</p>
<p><b>N-METHYL- 2-PYRROLIDONE &amp; AMMONIA</b></p>	<p>Asthma-like symptoms may continue for months or even years after exposure to the material ends. This may be due to a non-allergic condition known as reactive airways dysfunction syndrome (RADS) which can occur after exposure to high levels of highly irritating compound. Main criteria for diagnosing RADS include the absence of previous airways disease in a non-atopic individual, with sudden onset of persistent asthma-like symptoms within minutes to hours of a documented exposure to the irritant. Other criteria for diagnosis of RADS include a reversible airflow pattern on lung function tests, moderate to severe bronchial hyperreactivity on methacholine challenge testing, and the lack of minimal lymphocytic inflammation, without eosinophilia. RADS (or asthma) following an irritating inhalation is an infrequent disorder with rates related to the concentration of and duration of exposure to the irritating substance. On the other hand, industrial bronchitis is a disorder that occurs as a result of exposure due to high concentrations of irritating substance (often particles) and is completely reversible after exposure ceases. The disorder is characterized by difficulty breathing, cough and mucus production.</p>

#### Environmental Fate

NMP may enter the environment as emissions to the atmosphere, as the substance is volatile and widely used as a solvent, or it may be released to water as a component of municipal and industrial wastewaters. The substance is mobile in soil, and leaching from landfills is thus a possible route of contamination of groundwater.

In air, NMP is expected to be removed by wet deposition or by photochemical reactions with hydroxyl radicals. As the substance is completely miscible in water, it is not expected to adsorb to soil, sediments, or suspended organic matter or to bioconcentrate. NMP is not degraded by chemical hydrolysis. Data from screening tests on the biodegradability of NMP show that the substance is rapidly biodegraded.

This material is not expected to persist in the environment. It is water soluble and is expected to have low volatility. Hydrolysis is not expected to be an important factor in the environmental fate process for this material.
